Storage duration of the data	<p>Your data entered during registration will be stored until you submit a deletion request from your user.</p> <p>Our PLCnext community includes functions such as the possibility to participate in our forum by creating and commenting on posts. You can deactivate your personal user account using the "remove" function. In doing so, your e-mail address will be completely erased from the system and only the freely selected user name will remain in order to ensure traceability of the user actions within the assigned customer account. Thus, for instance, it must remain comprehensible for other users of a customer account which actions were each done within this customer account. When removing your user account the contributions that you posted in the community will be kept so as not to lose the context of a discussion.</p> <p>System log data will be deleted after 6 months at the latest.</p>
